Today's meetings were hosted by Andy and Stephanie Jurski. The annual board meeting was held at 1:00 followed by a region meeting at 2:00. Board members attending were Andy Jurski, Eileen Cufur, Art Lutz and Paul Svatik. Members at large attending were Stephanie and Bennett Jurski, Dave Cufur, and Donna Lutz. Jo Bair and Harold Cuthbertson joined later for the Region meeting.

Art Lutz presented the year end treasury report. Including the profit from the 58th Central Meet that was co-hosted by the Western Buckeye Region, our year end treasury balance was reported. **Eileen Cufur made a motion to accept the report, seconded by Jo Bair.**

Paul Svatik gave a brief report on bracket sales. One bracket was sold in January, none in February. We have a remaining supply of 172 brackets.

It was announced that well known "Pinky" Randall, better known as "Mr. Chevrolet" passed away. Also, the Mike Cook family was unable to attend today due to illness.

Today's topics of discussion were:

- Keeping meetings/tours shorter for families with young children. Also, many newer members have not participated in the many tours to area parks and Museums. These destinations could be repeated.
- developing a Google calendar to issue meeting reminders and invitations**
- Dave Cufur suggested a public gathering for Chevrolet owners that could be advertised at local car shows. We could provide hot dogs and beverages to introduce locals to the GCR. **Eventually discussion turned to having "Chevy cars and coffee."  - Paul Svatik will host the April 23rd meeting. We will be touring Fulton County. This is a tour that Paul designed for the fall, but, had to be postponed. Paul advised us to plan on a full day as the tour will cover 150 miles.**
